2023 Total call volume- 3,088

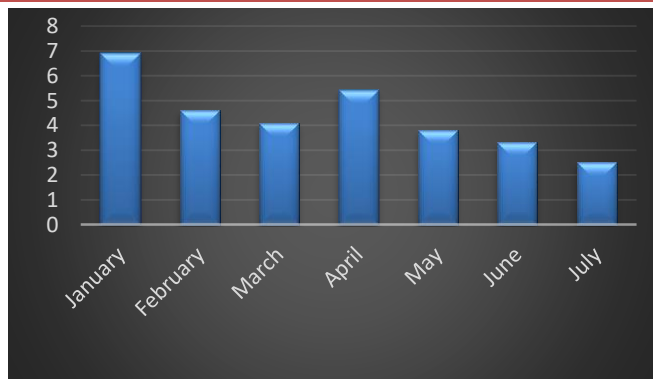
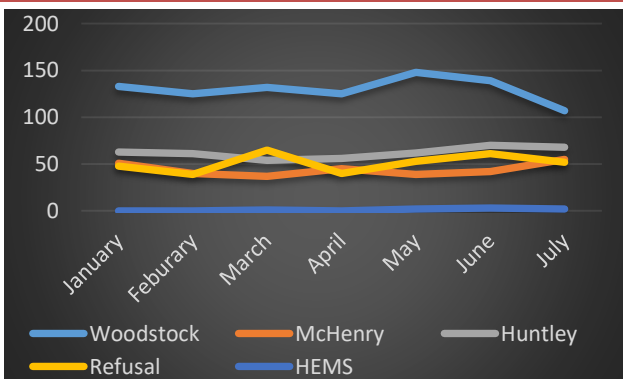
Call volume by month- 470

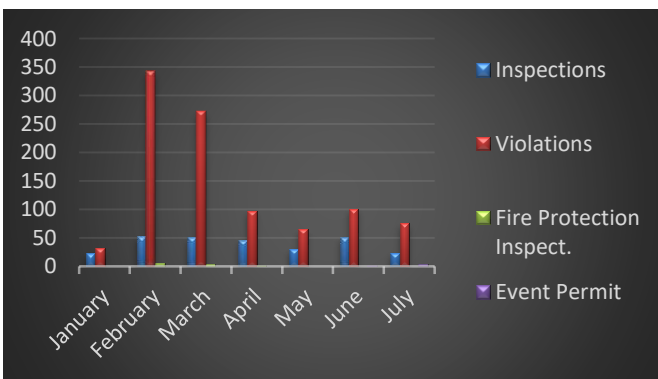

### Work Orders & Preventative Maintenance

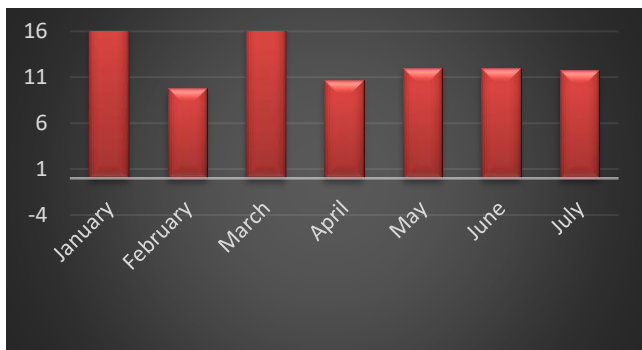
- A total of 100 work orders have been completed along with three preventative maintenance services.
