**ORDINANCE NO. 217**

**AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE WOODSTOCK FIRE RESCUE DISTRICT, MCHENRY COUNTY, ILLINOIS, PROVIDING FOR AND REQUIRING THE SUBMISSION OF A PUBLIC QUESTION TO INCREASE THE DISTRICT'S EXTENSION LIMITATION, TO BE SUBMITTED TO THE VOTERS OF THE DISTRICT AT THE CONSOLIDATED ELECTION TO BE HELD ON APRIL 2, 2019**

**WHEREAS**, the Board of Trustees (the "Board") of the Woodstock Fire Rescue District, McHenry County, Illinois (the "District") deems it advisable and in the best interests of the District and its residents to continue to provide fully adequate fire, emergency medical and other emergency services to and from points inside and outside of the District; and

**WHEREAS**, sufficient funds are not available to ensure the continuation of the foregoing purposes, and it is necessary and in the best interest of this District that this Board of Trustees seek to increase its extension limitation as provided for in 35 ILCS 200/18-205; and

**WHEREAS**, the Board hereby deems it advisable, necessary, and in the best interests of the District that the proposition authorizing the Board to increase its extension limitation be submitted to the voters of the District at an election to be held and conducted in accordance with the general election laws;

**NOW, THEREFORE, BE IT ORDAINED**, by the Board of Trustees of the Woodstock Fire Rescue District, McHenry County, Illinois, as follows:

**Section 1:** That the Board hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true, and correct and they are incorporated into this Ordinance by reference.

**Section 2:** That the following proposition shall be submitted to the voters of the District at the consolidated election to be held on Tuesday, April 2, 2019 between the hours of 6:00 a.m. and 7:00 p.m. on said day (the "Election"):

Shall the extension limitation under the Property Tax Extension Limitation Law for the Woodstock Fire Rescue District, McHenry County, Illinois, be increased from the lesser of 5% or the percentage increase in the Consumer Price Index over the prior levy year to 20% for levy year 2019?

- (1) For the 2019 levy year, the approximate amount of the additional tax extendable against property containing a single-family residence and having a fair market value at the time of the referendum of \$100,000 is estimated to be \$56.86 in McHenry County.

**Section 3:** That the Election shall be held in the voting precincts and at the polling places established by the McHenry County Clerk ("Election Authority") for voters of the District at the Election.

**Section 4:** That notice of the Election ("Notice") shall be given in accordance with the general election law of the State of Illinois in the Election Code by the Election Authority by (i) publishing the Notice once in a local community newspaper not more than sixty (60) days nor less than ten (10) days prior to the date of the Election; and (ii) posting a copy of the Notice at least ten (10) days before the date of the Election at the principal office of the respective Election Authority.

**Section 5:** That not less than 10 days before the date of the Election, the Secretary of the Board shall post a copy of the Notice at the principal office of the District.

**Section 6:** That it is hereby found and determined that The Woodstock Independent and The Northwest Herald are local community newspapers published in and having general circulation in the District as required by Sections 12-4 and 12-5 of the Election Code.

**Section 7:** That the Notice shall appear over the name or title of the respective Election Authority and shall include the following:

**NOTICE IS HEREBY GIVEN** that at the consolidated election to be held on Tuesday, April 2, 2019, the following proposition will be submitted to the voters of the Woodstock Fire Rescue District, McHenry County, Illinois:

Shall the extension limitation under the Property Tax Extension Limitation Law for the Woodstock Fire Rescue District, McHenry County, Illinois, be increased from the lesser of 5% or the percentage increase in the Consumer Price Index over the prior levy year to 20% for levy year 2019?

- (1) For the 2019 levy year, the approximate amount of the additional tax extendable against property containing a single-family residence and having a fair market value at the time of the referendum of \$100,000 is estimated to be \$56.86.

The polls will be open at 6:00 a.m. and continue to be open until 7:00 p.m. on that day.

**Section 10:** That the Secretary of this Board of Trustees shall, not less than sixty-eight (68) days before the Election, certify to the Election Authority the proposition as hereinabove set forth to be submitted to the voters of the District at the Election. Such certification shall include the form of the public question to be placed on the ballot, the date on which the public question was initiated by the adoption of this Ordinance, and a certified copy of the Ordinance, and shall be substantially in the form of **EXHIBIT A** attached hereto and hereby made a part of this Ordinance.

**Section 11:** That the Election shall be held and conducted and the returns thereof duly canvassed, all in the manner and the time provided by law.


